- >>: I will ask some questions that quite frankly will sound a little ridiculous but it's because I want to get a baseline as we go along. This to me is a big discussion. You are welcome to stay as long as you want because I like having people here but if you'd also like to check in
- 11 with some of the other tables and give your input on employment or emergency preparedness or accessible healthcare or transportation, that is totally fine as well. I will not hold it against you.
- Let me start with a question that's going to seem obvious but I don't think it is because I think different perspectives -- different people of different perspectives on this. What does guardianship mean to you?
- Other than taking off a box it says US of this meeting. What's the point of it in previous events, sure --
- >>: What is the purpose of this? Absolutely. So the purpose of the town hall especially the breakout stations right now is to help INSILC figure out what they want to do as part of their plans and efforts going forward.

- 15 >>: There was a states plan years ago saying they would do something and they never did.
- 16 >>: What I will also say -- we got interrupted. This is even worse on the last one. I will be quiet now.
- 17 >>: There's a lot going on in the guardianship realm in Indiana.
 - 18 >>: It's impossible to sit and say nothing.
 - 19 >>: It is.
- >>: I'm talking to my colleagues. The situation is this. In the world of independent living and the independent living movement, guardianship is something that should not have been. Because if you're living independently then what is -- you have control of yourself. Guardianship
 - 21 is probably one of the most abused.
 - 22 >>: Taken advantage of.
- >>: Yes, taken advantage of, control and a lot of times people that don't have your best interest, like providers or whatever --
 - 24 >>: Professionals.

>>: Yes. They are actually running the show and have no vested interest in you. They have no skin in the game, so to speak here and they are in control. It is actually the antithesis of what independent living is.

- 1 >>: So we said this before and it didn't go over well I am just asking, given the time, what is the purpose of her making that comment if it's going to go to the same people that did not act on it the last time.
 - 2 >>: I don't know that it's going to the same person.
 - 3 >>: I think that's a question for Mike.
- >>: I guess, okay. It is me. So I guess, again, I'm going to as the same question I asked the first time. Have they given you anything to do with this information? What is happening with it on your end?

- That's why there isn't a center for Independent living in this country that should be anywhere near guardianship CD they need to make sure that the people providing guardianship are doing it correctly but you should not be providing it.

- >>: A nursing home that is like being in a guardianship you know what the big beautiful bill that nursing home staffing and nursing homes requirement for minimal staffing in nursing homes was removed in the big beautiful bill.
 - 18 So what you think the cares and be like.
 - 19 >>: I can imagine it getting worse.
 - 20 >>: Well guess what.
- 21 >>: You all nursing homes closing was people that have jobs.
 - Early hiring the worst of the worst.
 - >>: No place for people to live.
- 24 >>: While witnessing is that more than half the people at the stable live in one place in that place gets cursed out for talking so much.

25 If we were talking how the conversation going to go there is one person you're impacted by this. We are not we just work with people.

- What I find frustrating is when people formulate their words put it together explain what their thoughts are and then nothing happens. They make these comments at the Nana meetings INSILC meetings in the minutes they ran a, Leslie said something and Jordan said something so how do
 - 2 their voices matter.
- 3 >>: They don't speed you will assign" is a QR code to go on the e-mail list.
 - 4 >>: People Susie I have no control over that.
 - 5 >>: I did not know that was the only way to register.
 - 6 >>: I don't hear you echoing my concerns.
- 7 >>: Holland know because he said it on the microphone while Anna announced on the microphone that it was just a QR code and that was only for the newsletter and that it wasn't a sign-up sheet and it was a survey and so is the point of these events is to create a community of people

- 8 who care about what's happening to them and have their voices heard and to have INSILC do something about it in an ideal world.
- How will that happen if you don't even know who's been here and I'm not saying this because you have control over it but you have input and you are somebody who can say something and maybe somebody might listen to you over us since we get yelled at for speaking her mind Susie or don't
 - 10 listen at all.
- 11 >>: You can make that comment at next meeting so it makes it into the minutes.
- >>: It's frustrating that we can talk about guardianship and alternatives to guardianship, and then we can make comments at meetings and there is no community whatsoever at the end of the day how will someone say well, Breanna had a really good point or Kristin something really cool.
- 13 I have no idea what her last name is or how to get a hold of her. I can't remember exactly what she said I just little cynical.
- How can we actually make change in the state let alone the country.
- How we do any of that when none of our comments make it to anyone who can help us make change and I'm sorry for feeling what I am very frustrated with this because it's been two years of me sitting

at these meetings and wasting I know I know where she's at after 30 years in two years

- 16 because it's so maddening to not be listening to and waste my time every single month every single meeting and have hours of my life wasted trying to get someone to listen to me.
- 17 >>: I did say guardianship when I said we have an estate plan that would do away with this 10 years ago.

- 5 advocate with and for each other when guardianship comes up but again, orders and we are really discussing it here at INSILC is because we have not had the experience where that means anything and at the end of the day the only person I've connected with is you and that's only because I talk to you
 - 6 before we set at this table because I wanted to talk to you.

- 7 If we want in-person which by the way, 99 percent of your meetings are not in-person I could do that because you don't leave the comments open you don't show people on zoom.
 - 8 There is no community there.
- At the start of anything is letting the people speak and you put a time limit on people and you cut people's Mike's and so how can they even speak when they can't unmute themselves to speak. You unmute them for them and.
- 10 >>: You decide it takes three minutes to make a comment what if you have difficulty speaking or talking through an interpreter doesn't matter you have three minutes.
 - 11 >>: If you can even provide an interpreter.
- >>: It really comes down to we need to inform people but we cannot do that if we don't know how to inform them or who to even talk to. And we also can inform them if we can't talk and if our voices aren't heard.
 - 13 >>: Or put into the record.
- 14 >>: I would like to have a INSILC meeting with the conversation.
 - 15 >>: Like this!

- 16 >>: Maybe might disagree but okay you allow people to express himself, like that.
 - 17 >>: I guess.

- What are we gonna do about that what can we do about that and four years ago there was in this state plan a plan for guardianship because they were told many times probably by us that there

were centers providing guardianship and that was not okay so they rode in a provision that said

- 17 we are implementing a three-year phaseout man of guardianship at centers and then all of a sudden we get the state plan rewritten and that is gone and Alice's guardianship is okay that creates a loophole that enables centers to provide guardianship services to continue to provide guardianship
- 18 services saying that it is the last resort. We just want to know what happened to that phaseout plan and every time I've asked about that I haven't gotten an answer.
- 19 And what's in the bill was copied from the department -- it wasn't actually written by anybody.
- I get frustrated because the state plan number one goal is to get more resources.
